PRIVACY OF PERSONAL DATA IN ACCORDANCE WITH DECREE LGS. 196/2003

We inform you, pursuant to art. 13 D. Decree 30 June 2003, No 196 (Law on the protection of personal data), which CANULLO MARINO SRL, will process the personal information from you in respect of the rights, fundamental freedoms and dignity of persons, with particular reference to privacy and personal identity as well, however, in compliance with the law on protection and treatment of personal data.

The conferment of data is voluntary, but refusal to provide those indicated by an asterisk determines the inability to access the services we offer. The personal information you provide is collected and managed by Information Technology and treated, even with the help of electronic or automated, directly and / or through delegated third parties (companies with proven reliability, specialized in home delivery, the postal and data entry) for the following purposes:

purposes related to the execution, management and payment of the purchase;

promotional advertising and informative material, including through the use of e-mail only if the customer has given consent by ticking in the registration phase, the box "Newsletter";

fulfillment of obligations under applicable laws, regulations and legislation.

In any case, your data will not be disclosed (if not a company for home delivery, for mailing and data entry), or sold to third parties. The data may be known as managers or agents only by those specifically designated, operating at the offices of ELETTROPOMPEGF.IT.

Under Article. 7 D. Decree 30 June 2003, No 196, you have the right to obtain confirmation of whether or not personal data concerning him, even if not yet recorded and their communication in intelligible form and a statement:

source of personal data;

the purposes and methods of treatment;

the logic applied in case of treatment with the help of electronic means;

the identity of the owner and managers;

the subjects or categories of persons to whom the data may be communicated or who may become aware of them as managers or agents.

You also have the right to:

updating, rectification or, when interested, integration of data;

the cancellation, transformation into anonymous form or blocking of data processed unlawfully, including data which need not be kept for the purposes for which the data were collected or subsequently processed;

certification that the operations referred to in points 1. and 2. have been notified, also as regards their content, to those to whom the data were communicated or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate to the protected right.

She finally has the right to oppose, in whole or in part:

for legitimate reasons the processing of personal data concerning him, even to the scope of the collection;

the processing of data concerning the purpose of sending advertising materials or direct selling or for carrying out market surveys or commercial communication.
